As per data of the Maharashtra government's health department, the total number of COVID-19 cases in Pune district reached 2,03,468 on Monday after 4,165 more people tested positive for the disease. Pune crossed the one lakh-mark on August 5 and in a month's time, the cases have doubled in the district, according to official figures. Compared to Pune, Delhi reported 1,93,526 COVID-19 cases till Monday, while Mumbai recorded 1,57,410 cases. The COVID-19 positivity rate in Pune is around 22 per cent, Collector Rajesh Deshmukh told news agency PTI today. "Currently, Pune district is on top in terms of the number of COVID-19 cases in the country. The reason behind the urge in cases is the aggressive testing strategy adopted by the district administration, "he said.
