CJI irked over persistent requests for early hearing, asks lawyer to sit on bench for day

"Sit here for a day. I assure vou, vou will run for vour life," a visibly-irked Chief Justice of India D Y Chandrachud told a lawyer when he kept persisting for an early date of hearing in a case related to disqualification of Shiv Sena MLAs.

A bench comprising the CJI and justices JB Pardiwala and Manoj Misra was fixing dates for hearing the two separate pleas related to the Maharashtra political disputes. The Uddhav Thackeray faction has challenged Maharashtra Assem-Speaker Narwekar's order declaring the Shiv Sena bloc led by Chief Minister Eknath Shinde as the "real political party" after its split in June 2022. SC to hear plea of NCPCR on child marriage

NEW DELHI, AUG 6 /--/ day agreed to list for hearing a plea of child rights body NCPCR seeking an authori tative pronouncement on a vexed legal question whether a secular law on prohibition of child marriage will prevail over the Muslim personal law.

A bench comprising Chief Justice D Y Chandrachud and Justices JB Pardiwala and Manoj Misra was urged by Solicitor General Tushar Mehta the plea of the National Commission for Protection of Child Rights (NCPCR) be heard on priority basis keeping in mind the different views being expressed by various high courts on the issue of child marriage. Some high courts are taking note of the personal laws on the issue and conflicting judgments are being rendered and may lead to filing of several special leave petitions (SLPs) in the top court, the law officer said. "Different views are being taken by different high courts. The issue is whether child marriage is permitted or not in one religion or another religion. We (NCPCR) arearguingonconstitutional principles," the law officer said. He urged the bench that the 2022 plea of the NCPCR be listed on "any Wednesday or Thursday" as new judgements from different high courts are being delivered and multiplying the appeals. "We have to settle the matter at once," the CJI said and agreed to list the plea for an early hearing. The plea of NCPCR was listed for hearing on Tuesday and it was unlikely to reach for hearing due to the ongoing proceedings on a batch of pleas related to taxation dispute. The Punjab and Haryana High Court, in 2022, in its judgement delivered in the case titled 'Javed vs State of Haryana' had held that a Muslim girl, after attaining puberty, can enter into a lawful marriage despite the fact that she has not turned major under the relevant secular laws. (PTI)

tion of the NCP challenging Narwekar's decision declar ing the group led by deputy Chief Minister Ajit Pawar as the real NCP.

Recently, the top court issued notices to Ajit Pawar and his 40 MLAs on the plea moved by the Sharad Pawar faction. At the outset, the CJI said in the Shiv Sena case the pleadings were complete. On listing of the NCP dispute matter, the bench took note of the submission of senior advocate NK Kaul, appearing for the Ajit Pawar group, that the three weeks time be given for filing response to the plea of the Sharad Pawar group. The court finally gave 10 days time to the Ajit Pawar group and its 40 MLAs for filing the response and said that the plea will be

heard after that. In the meantime, a lawyer, apparently appearing for the Uddhav Thackeray faction, started persisting with his submissions that an early date be given. He said the Maharashtra assembly polls are round the corner and the matter be listed early. The lawyer added that the common compilation of documents can be prepared within two-three days. "Please do not dictate the court," the CJI said. "Why don't you come and sit here just for one day and tell the court master as to what dates you want. Ultimately you see this is too much. You see the kind of pressure of work on the court's ..., please come and sit here. Sit for a day. I assure you that you will run for your life!," the CJI said.

The assembly speaker, on January 10, declared the Shiv Sena bloc led by CM Shinde as the "real political party" after its split in June 2022. The speaker had also dismissed the disqualification petitions of the Thackeray faction against CM Shinde and his supporting MLAs. The speaker, on February 15, held that the NCP faction led by Ajit Pawar, who rebelled against his uncle Sharad Pawar and joined the BJP-Shiv Sena government in Maharashtra, was the real NCP. The speaker had also rejected the disqualification petitions filed by the rival NCP factions seeking disqualification of each other's MLAs. (PTI)

Cong-led Himachal govt doing nothing to help victims: Kangana in disaster-hit Samej village

SHIMLA, AUG 6 /--/ Actor-MP Kangana Ranaut on Tuesday visited disaster-hit Samei in this district and accused the State government of doing "nothing" to help the victims.

'Yeh dil dehla deni wali trasadi hai' (it is a heartwrenching tragedy). People have lost all their family members, including children. They are terrified and in trauma. I would request the State government to provide immediate relief (financial assistance) to the affected families." Ranaut. who interacted with the flashflood victims in Samej in Rampur subdivision, said. The BJP MP from Mandi also demanded a special inquiry into allocation of funds by the Congressled Himachal Pradesh government to the flood-affected families last year.

Himachal Pradesh has been pummelled by heavy rains for almost a week. Fourteen bodies have been recovered so far and 40 people are still missing after flash floods triggered by cloudbursts hit Kullu's Nirmand, Sainj and Malana, Padhar Mandi's and Shimla's Rampur subdivision on the night of July 31, officials said. "Malana in Kullu district has been disconnected and the villagers are themselves making the bridge," Ranaut said.

She accused the State government of doing "nothing" to help the affected people in Samej village, where over 30 people are missing. "I cannot see anything being done by the State government. Not a single thing has been done here by ministers which is inhuman," the BJP leader alleged. Samej village, about 148 km from here, has been worst hit in the flash floods. Rampur, Kullu and Mandi are under the Mandi parliamentary constituency from where Ranaut was elected in the recently held Lok Sabha polls. "I have come as a repre-

sentative of the Union government. The Union government will provide funds to help the flood-affected people but we all know that financial assistance was also given last year after the monsoon disaster. These funds go to the State government and are distributed by them," she said. "No one knows what happened to those funds. The Union finance minister, during her recent budget speech, also Himachal Pradesh but the funds would come through the 'ditch' (khada) created Chief Minister Sukhvinder Singh Sukhu. Only God knows if the money will be distributed or not among the affected families," the BJP MP said.

"Himachal has been facing disasters ever since the Congress came to power in the state," she said, claiming the people affected by last year's disaster are still waiting for the promised Rs 7 lakh by CM Sukhu. Prime Minister Narendra Modi had provided an Rs 1,800 crore package to the state after the disaster last year, Ranaut added. According to the officials, 410 rescuers from the Army, NDRF, SDRF, ITBP, CISF, Himachal Pradesh Police and home guards are involved in the search operation, which has been intensified with additional machinery, sniffer dog squads, drones and

other equipment. The hill state has suffered a loss of Rs 684 crore since the onset of the monsoon on June 27 until August 5. Eighty-seven people have lost their lives in rain-related incidents, according to the state emergency op-

DEHRADUN, AUG 6 /--/ Uttarakhand Chief Minister Pushkar Singh Dhami announced on Tuesday helicopter services in Kedarnath will resume from Wednesday with pilgrims getting a concession of 25 per cent on Dhami met with senior

officials in Rudraprayag on Tuesday to review the relief and rescue operation in the rain-ravaged Kedarnath trek route. "The damage is of large scale. The route has been breached at 29 places due to landslides. Water and power supply lines have been hit, besides disruption totelecommunication lines,' the chief minister said. An alternative route for pilgrims should be readied and new helipads should also be built, he added. "But collective efforts made by the disaster management department, the district administration, the SDRF, NDRF, the priest community, and public representatives helped in rescuing such a large number of people," the minister said. Dhami also said the rescue work is almost over and the entire focus now is on how to resume the yatra by repairing the damaged infra structure en route to the Himalayan temple, he said. "However, the helicopter service to Kedarnath is beginning from tomorrow. The pilgrims who go for a darshan to the temple by helicopter will get a rebate of 25 per cent on their tickets," Dhami told reporters. (PTI)

Heavy showers trigger flood-like situation in Rajasthan's Jaisalmer, Pali, Jodhpur JAIPUR, AUG 6 /--/ Extremely heavy rain- Superintendent of Police (SP) Sudheer

fall occurred in Rajasthan's Jaisalmer, Pali and Jodhpur districts during the last 24 hours, leading to flood-like situation at some places, officials said on Tuesday

Disaster management teams, equipped with mud pumps and tankers, have been deployed in the affected areas to remove water and provide assistance to people, the officials said. According to Meteorological Centre, Jaipur, Mohangarh and Bhaniyana in Jaisalmer district recorded 260 mm and 206 mm of rainfall, respectively, till 8:30 am. During the same period, Pali recorded 257 mm and Dechu in Jodhpur district 246 mm of rain, the weather office said.

Other areas within these districts also experienced heavy to very heavy rainfall, it said. Jaisalmer collector Pratap Singh and

Choudhary conducted field visits in rainhit areas and took stock of the situation. Singh said there is waterlogging at some places and civil defence, SDRF and police teams will be reaching those areas to provide assistance. The Met centre has issued a warning of heavy rain in several places in the state, particularly in western Rajasthan.

Over 50 students of ashram schools hospitalised due to suspected food poisoning

PALGHAR, AUG 6 /--/ At least 50 students from around 10 ashram schools in Dahanu taluka Maharashtra's Palghar district fell ill due to suspected food poisoning on Tuesday morning and were admitted to hospitals, officials said.

Ashram schools are residential schools for tribal students. "More than 50 students from different ashram schools under the Dahanu Project of the Integrated Tribal Development Project (ITDP) complained of nausea, vomiting and giddiness following which they have admitted to different health facilities in the district, Palghar Resident Deputy Collector Subhash Bhagade said. "The cause of the food poisoning is being probed. The students admitted to hospitals are undergoing treatment," he said.

The affected schools are located in Dahanu, Palghar, Talasari and Vasai talukas of the district, officials said. As per an official report, students of an ashram school at Rankol in Dahanu complained of vomiting, nausea, stomach pain and fever hours after consuming
